Baseline Emissions Footprint



Baseline Year: 2024



Above is the same report for January 2025. ABC Translation will report annually, with our reporting year end **no more than 12 months from the date of the Framework Agreement commencement**, ensuring compliance with government standards.



Emissions Reduction Targets

To continue progressing toward **Net Zero by 2050**, we have adopted the following carbon reduction targets:

We project that carbon emissions will decrease over the next **five years** to **5197 tCO₂e by 2029**—a reduction of **6.96%**.

Our long-term goal is to progressively reduce emissions in line with industry benchmarks.

Progress against these targets will be reviewed annually and reflected in our emissions reporting.



Carbon Reduction Projects

Completed Carbon Reduction Initiatives

Since establishing our baseline in 2024, ABC Translation has implemented several **environmental management measures** to reduce our carbon footprint, including:

- Energy Efficiency: Adoption of energy-efficient office equipment.
- **Paperless Operations:** Transition to digital document processing to minimise paper waste.
- Sustainable Travel Policy: Encouraging virtual meetings to reduce travel emissions and promoting public transport.
- **Eco-Friendly Procurement:** Partnering with suppliers that demonstrate sustainability commitments.

These initiatives have resulted in a reduction of **327 tCO₂e**, representing an **5.85% decrease** from our baseline year.



Future Carbon Reduction Initiatives

To further reduce emissions, ABC Translation plans to implement additional measures such as:

- Switching to 100% renewable energy sources for office operations.
- Electrifying our transportation methods and further reducing business travel emissions.
- Improving where possible, through expansion, the current waste reduction and recycling programme.



Declaration and Sign-Off

This Carbon Reduction Plan has been completed in accordance with **PPN 06/21**, associated guidance, and the standard reporting framework for Carbon Reduction Plans.

Emissions have been reported in line with:

- The GHG Reporting Protocol corporate standard (GHG Protocol).
- The UK Government's carbon reporting conversion factors for company reporting.
- The SECR (Streamlined Energy and Carbon Reporting) requirements for Scope 1 and 2 emissions.
- A required subset of **Scope 3 emissions**, aligned with the **Corporate Value Chain (Scope 3) Standard**.
